#### **EVENTIE**

#### PRIVACY POLICY

Your privacy is very important for us. We are also aware of the importance of your privacy for you. With this aim, the Eventie Privacy Policy aims to inform you of how and for which purposes your personal data may be processed and shared with third parties. This Policy covers information on our entire operations.

Your personal data is recorded, updated, and maintained to the extent permitted by the purpose of processing, shared with third parties in Türkiye and abroad, and otherwise processed as stipulated by the law, by Eventie, or on its behalf as the data controller, in each case subject to the applicable law and the rules stipulated in this Policy.

This Privacy Policy for Eventie ("we", "us", or "our") describes how and why we might collect, store, use and/or share ("process") your information when you use our services ("Services"), such as when you:

- i. Download and use our mobile application (Eventie), or any other application of ours that links to this privacy policy,
- ii. Engage with us in other related way.

#### 1. What information do we collect?

We collect personal information that you voluntarily provide to us when you register on the Services, express an interest in obtaining information about us or our Services, when you participate the activities on the Services, or otherwise when you contact us.

The personal information that we collect depends on the context of your interactions with us and the Services, the choices you make, and the Services you use. The personal information we collect may include the following:

- i. Name and Surname
- ii. Phone Number
- iii. Location data

All personal information that you provide to us must be true, complete, and accurate and you must notify us any changes to such personal information.

#### 2. What legal bases do we rely on to process your information?

We only process your personal information when we believe it is necessary and we have a valid legal reason (i.e. legal basis) to do so under applicable law, with your consent, to comply with laws, to provide you with services to enter into or fulfill our contractual obligations, to protect your rights, or to fulfil out legitimate business interest.

Eventie may process your personal data without your consent if at least one of the following lawful grounds for processing exist:

- i. Processing is clearly permitted by law.
- ii. Processing is necessary to protect the vital interests of the data subject or of another natural person.
- iii. Processing is necessary for the performance of a contract to which the data subject is party or to take steps at the request of the data subject prior to entering into a contract
- iv. Processing is necessary for compliance with a legal obligation to which the controller is subject.
- v. Personal data is publicized by the data subject.
- vi. Processing is necessary to establish, exercise or protect a legal right.
- vii. Processing is necessary for the purposes of the legitimate interests pursued by the controller or by a third party, except where such interests are overridden by the interests or fundamental rights and freedoms of the data subject which require protection of personal data.

### 3. How do we use and process your data?

Eventie may process your personal data for the following purposes, without your consent to the extent such processing is based on at least one lawful ground.

- i. Enable communication between users
- ii. Improve and administer our Services
- iii. For security and fraud prevention
- iv. Comply with law
- v. Complaint and request management
- vi. Responding to and managing user information requests by official authorities
- vii. Marketing activities and user satisfaction
- viii. Improving search results based on location and advertising based on user location
- ix. Carrying-out financial operations
- x. Legal compliance review

### 4. When and with whom do we share your personal information?

Eventie may transfer your personal data to the following recipients, either based on your consent or without your consent if any other lawful basis listed in the article 3 above apply.

- i. Business partners with whom we offer services and/or products
- ii. Employees, service providers, partnerships, in each case participating in the performance of our services
- iii. Competent official authorities, authorized to seek out information from Eventie and other persons and entities to the extent imposed on Eventie by legal obligations,
- iv. Our hosting service provider in AWS to keep the mobile application running.

## 5. Do we use cookies and other tracking technologies?

We may use cookies and other tracking technologies to collect and store your information. When you visit the Eventie Mobile Application, you can make your choices on cookies upon being prompted by our cookies privacy notification.

# 6. How long do we keep your information?

Eventie retains user data for as long as necessary for the purpose unless otherwise required by law. Users may request account deletion through the Eventie Mobile Application.

Eventie retains user data for as long as necessary for the purposes, which vary depending on data type, the category of user to whom the data relates, the purposes for which we collected the data, and whether the data must be retained after an account deletion request for the purposes.

#### 7. Do we make updates to Eventie Privacy Policy?

Yes, we may update this policy as necessary to stay compliant with relevant laws. All changes to the Eventie Privacy Policy are announced and updated on the Eventie Mobile Application. You will be deemed to have read and accepted the latest version of the Eventie Privacy Policy each time you use our Mobile Application, including any amendments to date.

#### 8. How can you contact us about Eventie Privacy Policy?
